## **INTERNAL AUDIT REPORT 2018-19**

---

I am pleased to report to Members of the Parish Council that I have completed my internal audit of the Parish Council's records for 2017-18 and have been able to complete the Annual Internal Audit Report (AIAR) for the 2018-19 Annual Governance & Accountability Return.

Members should be aware that the audit tests that I undertook during the audit cannot be relied on to identify the occasional omission or insignificant error, nor to disclose breaches of trust or statute, neglect or fraud which may have taken place and which it is the responsibility of the Members of the Council to guard against through the Parish Council's internal control procedures.

Members will be pleased to know that I did not find anything major in my financial audit to report and that I found the record keeping to be of a good standard and the Parish Council's approach to the management of risks to be sound. As a result of my audit and my discussion with your Clerk I was able to answer 'YES' to all the relevant questions contained in the AIAR for 2018-19.

I would like to take this opportunity to thank your Clerk for the assistance given to me in the conduct of the audit that took place on 28 June 2019.

### **PREVIOUS AUDITS:**

#### **External Audit Certificate 2017-18:**

The External Audit Certificate for 2017-18 was issued in two parts, firstly a holding certificate in the normal format dated 28 September 2018 and followed by a letter dated 15 October 2018 which bore the final certificate. The final certificate had one qualification for failure to complete Box 7 of the Governance Statement.

I was unable to find a minute showing that the Council had considered the auditor's letters (as required by the Accounts and Audit Regulations) and having discussed the matter with the Clerk the Auditor's reports will be taken to the next meeting of the Council.

#### **Internal Audit 2017-18:**

I had raised the matter of external auditor's reports not being considered by the Council in my 2016-17 and 2017-18 reports.

I note that the precept for 2019-20 set at the meeting on 8 January 2019 does state the amount of the precept. The minutes do not formally say that the 2019-20 precept was approved.

### **FINDINGS THIS VISIT:**

During the visit I carried out sufficient work to enable me to complete the AIAR for the Annual return which included reading the minutes, checking the accounting records including the cashbook, payroll, VAT records, bank statements and bank reconciliations with the cashbook.

I have nothing further to report, see above for follow up from items raised in previous years..
