


#### SELLINDGE VILLAGE HALL TABLE TOP FAIR

#### PROPOSED PERMANENT M20 LORRY AREA

In the 2015 Autumn Statement the Government set funds aside to build a permanent area where lorries can wait their turn to cross the Channel and do not cause disruption to local people or the economy. The Chancellor stated the Government's preference for a site at Stanford but was clear that alternatives would also be considered on an equal basis ahead of making any final decision. The Government wishes to fully test the case for a permanent lorry area as an alternative solution to Operation Stack, where lorries are temporarily queued on the M20 when there are delays and closures at the Port of Dover and Eurotunnel. A number of temporary solutions have previously been tried and investigated, but none have provided a satisfactory resolution.

It has not yet been decided on whether any Lorry Area will be used solely as a response to Operation Stack, with a number of other uses under consideration. The main alternatives comprise:

**1 - Emergency Use** – For use as a Lorry Area to accommodate lorries currently queued as part of Operation Stack.

**2 - General Disruption** – Emergency lorry holding area which reduces or removes the need for Operation Stack and also for the existing queue management on the A20 approaching Dover and/or on the M20 approaching the Eurotunnel terminal.

**3 - General Disruption and Overnight Parking** – Emergency lorry holding area as above, additional chargeable basic overnight parking. Free parking provided for lorries held for queue management or Operation Stack.

**4 - General Disruption and Truckstop** – Emergency lorry holding area as above plus a truckstop (a lorry focussed motorway service area). Free parking provided for lorries held for queue management or Operation Stack.

This consultation is a non-statutory consultation to enable us to obtain a broad range of feedback on general options and in due course it will be followed by a formal consultation on any preferred site that will include greater detail on the design, layout and operation, and any associated, necessary highway works.

Your Council met on 8<sup>th</sup> December, the normal second Tuesday in the month and it is expected that the meetings will continue in this manner during 2016. The dates for the monthly meetings are normally in each edition of the News. Although the headings on the agenda appear the same the content is usually different.

**Planning** – The first of the Highways England exhibition to show the proposed lorry parking solutions to Operation Stack (OS) will have taken place by the time this goes to print and it is expected there will be opposing opinions. There will be two representatives from Shepway District Council at the next Parish Council meeting.

In addition your Council is also a member of the group looking at the changes to M20 Junction 10 and the new M20 10a junction that is being developed. Another meeting is due to take place later in the New Year, any outcomes will be made public via the Sellindge Newsletter. Both these proposed developments are being led by central government so it will take sound constructive statements to make them listen to the comments being put forward by local people. The lorry parking at the Airport Café and Otterpool Quarry continues to cause a nuisance to local people, your Council along with Shepway Councillors continue to monitor and reply to the planning department at Shepway when any new information is sent.

A Development Company called Quinn Estates (QE) have submitted an application to Shepway District Council to have the Bucknell Trust land listed for development in the next Shepway Local Plan. Your PC have already explained to QE that the replies from our first consultation on our Neighbourhood Plan did not want to see any further large developments take place. Unfortunately this does not stop QE from making the submission to SDC and it will be up to the planning policy team at Shepway to make the final decision as to whether or not this land will be included in the new Local Plan. Your Council continues to monitor the situation and will be responding accordingly when the New Local Plan is out for consultation, although dates for the consultation are yet to be confirmed.

**Neighbourhood Plan** – Due to the extra consultation taken close to the Christmas holidays it was agreed by the working group to delay any further meetings until late in January. Again new information will be passed on in this Newsletter. According to the Group leader Mr Jim Boot both events in Sellindge Primary School and Brockhill School went well. A brief outline of issues put forward by the children at Sellindge was considered, in the main their comments were well thought out and useful. More work is needed on the report though and this will be taken to the PC after the working group have considered it.

**Correspondence** – There were two items listed, 1 was the letter from the National Grid, which was a copy sent to residents in Sellindge who would be affected by the work taking place at the Converter Station and no. 2 was a consultation document on the future of the Community Infrastructure Levy (CIL) needs a response from your Council. **Other items** – After the PC meeting it was noted that our PCSO has changed – again – his name is David Garland and he can be contacted via the police 101 number. By dialling 101 it will take you directly to the Kent Police Customer Services and then you can ask to be put through to him, or any other department.

The mince pies, fruit juice and wine supplied by the Chairman was enjoyed by those who stayed after the meeting, it made a pleasant end to the last meeting of the year.

**Dog Poo Bags** – Your Council is still providing these for use free of charge, members consider that this has made a difference to the village. The Chairman and Councillors would like to say 'thank you' to all those who are taking the time and trouble to pick up after their dog/s.

The first of the 2016 meetings is on 12<sup>th</sup> January, in the Durling hall at 7.30pm so please do come along

#### **PROPOSED M20 JUNCTION 10a**

Some of you may think, I remember something like this before. Well you are right, a community consultation took place in 2008. There was a proposed option and 2 alternatives. The consultation found that the proposed option was the preferred option. In 2010 the proposed plans were shelved, and re-started in 2015. Now we have the 2<sup>nd</sup> round of the consultation which starts on Thursday January 14th until Thursday March 16<sup>th</sup>. Jenny Hollingsbee@shepway.gov.uk 01303 812 066 susan.carey@shepway.gov.uk 01303 670 561 Most people will be well aware of the government's proposals for a permanent lorry park at one of two alternative sites near Stanford. Highways England have launched a non-statutory consultation called 'Managing freight vehicles through Kent' (go to www.gov.uk and search for this title to find a copy online).

As well as the two sites there are four options for each site:

Alternative 1 – use the site only during Operation Stack.

Alternative 2 – use during Operation Stack and to avoid TAP (when traffic is slowed on the A20 approaching Dover and which then backs the traffic up as far as Folkestone) which now happens several times a week. Alternative 3 - As alternative 2 plus provide overnight parking to avoid the flyparking that takes place across our district by lorries.

Alternative 4 – As 3 plus a full Motorway Service area.

Site 1 at Stanford West would have access from a slip road on the M20 and lorries could both enter and leave the site without using local roads. It is also less prominent visually and makes use of the existing facilities at the Stop 24 site (it would be on both sides of the M20). Site 2 at Junction 11 North would bring the lorries off the motorway at the existing Junction 11 slip road and they would turn left onto the B2068 (Stone Street going to Canterbury). They would then travel a short way along this road to a new roundabout which would allow them to turn right into the site. Our view is that we don't want a giant lorry park at all but that site 1 is the 'least bad' option because of the direct access on and off the motorway. Of the alternatives, we believe alternative 3 is preferable as it would be used for our year round problems and not just Stack. We are against alternative 4 (the full motorway service area) as it would add to the noise and light pollution as well as taking up land that could otherwise park lorries.

The proposal is totally outside the normal planning procedures and **does not require permission from either Shepway District Council or Kent County Council**. Decisions will be made by the Secretary of State for Transport using his powers in the Highways Act.

In addition to the exhibitions that have already been held, there will be staffed exhibitions at the Civic Centre in Folkestone on 4<sup>th</sup> and 5<sup>th</sup> January, Sellindge Sports and Social Club on 11<sup>th</sup> January and Hawkinge Community Centre on 12<sup>th</sup> January.

We are both dismayed at how little detail there is about the two sites in the consultation just vague blobs on a map but there is no doubt the sites would be vast and (even with screening) will be a terrible blot on our lovely landscape. Whether you support or oppose the proposals you only have till midnight 25 January 2016 to respond to Highways England, please make your voice heard.

Meanwhile, Shepway's officers have issued over 100 Fixed Penalty Notices a week to lorries parked in the new restricted areas which include the A20 through Sellindge. The notices have been up since November and the fines started mid-November so it is too early to judge the effects but we will keep you updated.

A combination of low barometric pressure and winds of up to mid 40mph from the west or south west combined with high pressure from Europe made the weather unusual for a November. Sunshine was down on average but the temperatures both day and night were around  $3^{\circ}$ C above normal. The first frost of the winter was not recorded until Sun.22<sup>nd</sup>. Rainfall from 17 days was 74.93mm (2.95in) only 76.62% of the average for the month.

Most of my time at County is taken up with the budget which gets harder to balance every year. It's not just that our government grants reduce, but also that demand for social services continues to rise. The Chancellor has now announced that government grant will be phased out entirely by 2020 and just before Christmas we received the news that the grant made to Kent for 2016/17 would be reduced £111m (down from £161m this year) which is worse than our most pessimistic assumptions.

The government recognises that there has been rising demand for social care from an ageing population and has said that an extra 2% council tax can be levied specifically for this. For Kent this would raise £11m which is well short of what's needed. We now face some very unpalatable choices and a busy time as we have to publish our budget by  $11^{\text{th}}$  January if it is to meet the deadlines for scrutiny and debate.

There are two pieces of good news. Work begins this month (January) on the next phase of the superfast broadband project for rural areas which has been jointly funded by KCC and the government. If you go to <u>www.kent.gov.uk</u> and search for 'broadband' you will find a postcode checker which will show if you are covered by this latest programme will take broadband coverage in Kent to over 95% of households. The Prime Minister has promised that broadband will be available to all households but we do not yet have any details on how this will be delivered or funded. The second piece of good news is that (via KCC) the Government has allocated £5.1m to help get the Folkestone seafront development under way. The grant will fund flood protection measures, upgrades to utilities and improvements to Marine Parade.
