On 2 December 2011 Folkestone & Hythe became the first District Council in the country to commit to the Armed Force Covenant, a promise that those who serve or served in the forces and their families are treated fairly and not disadvantaged in their daily lives. Ten years on (on 03 December to be precise), a refreshed pledge was signed by Folkestone & Hythe District Council Chairman Councillor Philip Martin and Major Peter Houlton-Hart MBE, of The 1st Battalion Royal Gurkha Rifles (RGR), at Westenhanger Castle. Last month, your District Council received the Employer Recognition Scheme Gold Award from the Ministry of Defence; this is the highest badge of honour for military support.

There's some good news about air quality in our District. The 2021 report on air quality in 2020 found no incidences of high levels of Nitrogen Dioxide Gas at monitoring sites which means the District Council does not need to declare any Air Quality Management Areas. The Department for Environment, Food and Rural Affairs has now formally accepted the report.

Most street lights in Kent are owned and maintained by KCC but there is still a significant number owned by Folkestone & Hythe District Council. The District Council has decided to upgrade all its 1,063 lights to LED and transfer ownership of 340 of them to KCC. The whole project will cost £815,034 but will reduce running and maintenance costs so will save money (an estimated £2 million over 20years). Importantly it will also reduce carbon emissions.

Fly-tipping is a criminal offence and, together with Kent Police, your District Council is responsible for taking enforcement action against those who blight our countryside and towns. We are therefore pleased to report that 9 people have recently been successfully prosecuted for separate fly-tips which included sofas, beds and a mattress. All such waste can be taken for recycling at KCC's Household Waste Recycling Centres without charge or collected and disposed of properly for a small charge by the District Council. If you have evidence of fly-tipping (CCTV or eye witness accounts) do please report this to Kent Police or the District Council.

Congratulations to Sellindge Tennis Club that has been raising funds in double quick time to resurface their tennis courts. The tennis courts were relaunched on 26 November by our MP, Damian Collins.

Jenny attended Sellindge Parish Council on 14 December and we both attended Stanford Parish Council on 08 December.

We wish everyone all the best for the year ahead. Keep safe and we look forward to seeing you in 2022.

Thank you to those of you who responded to our consultations on the Budget and the Household Waste Recycling Centre booking system – we had over 2,000 responses to the first and over 10,000 to the second and the responses will help shape policy. You'll find current KCC consultations on https://letstalk.kent.gov.uk/ including one on the library service and another on the Kent Waste and Minerals Local Plan which sets out where building materials such as sand and ragstone can be extracted.

I often report to you about financial challenges and this year is different only so far as we have very little room for manoeuvre as the numbers of people eligible for care from KCC continues to rise. This includes care of the elderly, child protection and both the schooling and transport to specialist provision of children with Special Educational Needs (SEN). As an example, the number of children needing transport to an SEN school has risen by 13% since September. Our budget for 2022/23 will be debated and set in February.

On a more positive note we continue to be successful in winning one-off Government grants and we are through to the final round for a project that would bring significant funding to support tree establishment across Kent. We have also been shortlisted for several awards and have recently won the 'people's vote' award at the European Regiostars Awards for one of our drainage projects (a new park created in Margate that can store water to reduce flooding).

Our mobile library fleet (fleet makes it sound vast but it's just five vehicles) won a National Award. Finally, KCC is working with the Kent Resilience Forum in readiness for any disruption at our borders in the year ahead. We are lobbying the Government for additional freight holding facilities outside Kent, streamlined (ideally digitalised) systems for border checks, funding for the safety checks Kent Trading Standards need to make on imported consumer goods and major road improvements to deal with pinch points on the key arterial routes to Dover port. 
