I was very sorry to hear about the recent death of Cllr Stanley Bull. Stan gave great service to his community and was a stalwart Parish Councillor, chairing the council through some difficult times. He was also a kind man and will be missed not least by me.

It looks set to be a year of great change for all the current District Councils, Kent County Council and Medway Council. On 16 December the Government published a White Paper announcing new Unitary Councils and Mayoral Strategic Authorities (MSAs). The choice we face in Kent is either to opt for the Devolution Priority Programme (DPP) with the incentive of more devolved powers and funding for transport, skills and support for business or to go through the same process slightly later with a less generous settlement. The matter is being debated at an Extraordinary Meeting of the County Council on 09 January to meet the Government's 10 January deadline to be considered for the DPP.

If the government agrees that Kent can be part of the DPP, then we would be committed to have elections for an MSA in May 2026 and to reorganise Medway Council, KCC and the 12 District Councils by either April 2027 or April 2028. This would likely lead to the postponement by the Government of this May's County Council elections as KCC would soon cease to exist. The new Unitary Councils would combine the present services delivered by the County Council and District Council which many see as having potential for better and more cost-effective services. The Government wants to see each unitary cover a population of around 500,000, the MSA would cover the whole of 'historic' Kent (both KCC and Medway areas). This massive change being done at breakneck speed but the Government has made it clear that this is to be the new system for all parts of England. (To be clear these changes do <u>not</u> affect any Parish/Town Councils.)

In contrast to the haste for the change in Local Government organisation, the Government has also announced that it is setting up a commission to examine Social Care which will report in 2028. This is disappointing as this is an urgent problem which has had many past reviews and, if not resolved, has the potential to bankrupt local government. Social care used to consume a third of KCC's spending twenty years ago but now takes two thirds which means all other KCC services are deprived of funding. As a rural area I know many of our residents are aware of the impact the changes to Agricultural Property Relief (aka the Family Farm tax) will have on the viability of family farms, the rural economy and the environment. At the meeting of the Full Council at KCC on 19 December we debated a motion condemning the Government's Family Farm Tax. I spoke in the debate and I'm pleased to report that the motion passed with no votes against with just the Labour Group abstaining. Nearly every County Council has now passed a similar motion which helps show the support British farmers have from their local communities. To end with some good news. Several teams within KCC have been externally assessed as providing exceptional service including our Library Service and our Audit Team.

SELLINDGE WALKING GROUP

District Councillors' Report February 2025

We decided to do a joint report this month on the very important decision taken by KCC and Medway Council that will completely change our electoral landscape.

Devolution and Local Government Re-organisation

On 10 January 2025, Cllr Roger Gough, Leader of Kent County Council and Cllr Vince Maple Leader of Medway submitted an expression of interest to the Government asking that Kent and Medway be considered as a priority area for Devolution. The decision to put Kent forward was taken by KCC Cabinet Members at a meeting on 9 January.

Big changes lie ahead for local government in our area. Under the proposals there will be a directly elected mayor and all 14 councils in Kent will be abolished and replaced by a small number of much larger unitary authorities. The exact detail of what will come next is still to be determined. Although the Leader and Chief Executive of FHDC have attended many meetings, the decision to put Kent & Medway forward to the DPP programme was out of our hands.

Joining the Priority Programme could mean that this May's Local Elections will be postponed. In his letter of 16 December, Jim McMahon MP, Minister of State for Local Government and English Devolution, stated that to deliver both devolution and reorganisation according to the exacting schedules of the Devolution Priority Programme he was minded to lay secondary legislation to postpone local elections from May 2025 to May 2026. Acceptance on to the Devolution Priority Programme will commit Kent and Medway to elections to a new Mayoral Strategic Authority (MSA) in May 2026 and implementation of local government reorganisation by either April 2027 or April 2028. It is understood that the Government will notify the Leaders of KCC and Medway by the end of January as to whether or not they have been selected for the Devolution Priority Programme.

It is expected that the Government will ask the 14 Kent Councils collectively to submit one (or more) schemes for the local government re-organisation. An indicative proposal will need to be submitted in March with a confirmed version in the autumn. At this point there will be a formal consultation with residents.

Reading the Devolution White Paper, we can only find one reference to Town and Parish Councils which is as follows - "We know people value the role of governance at the community scale and that can be a concern when local government is reorganised. We will therefore want to see stronger community arrangements when reorganisation happens in the way councils engage at a neighbourhood or area level. We will also rewire the relationship between town and parish councils and principal Local Authorities, strengthening expectations on engagement and community voice."

This is just the beginning – there will be so much work to do. Please watch this space as we will provide regular updates on the situation.

The District Council own the building and are looking to create housing units for local people and are still considering the next stage for Everist Court. I have asked that the Community be consulted before any decision is finalised.

Housing targets – at a recent Planning Briefing, we were informed that the Government housing target for our District has been increased from 735 per annum to 859 per annum! Currently the District is far below the target and has been for quite a few years. There has recently been a 'call for sites' and the Government is asking for Local Plans to be revised.

On a personal note, I am very saddened by the sudden death of Stan Bull. Although, often called Pip, I always called him Stan. I had known him almost all of his life as his father and other members of the family worked for my family. Stan has always been a popular figure around the Village and has devoted many hours to the Parish Council, undertaking a whole range of tasks. He was always on hand if anyone needed help. My thoughts are with Mary and the family at this time.

Unfortunately, just having heard about Stan, I was also informed that George Oakley had died and again my thoughts are with Margaret and the family. George was a very active member of the Sports & Social Club and was the leading light in raising funds and implementing the new playground away from the road and in a better position for parents to watch their children. We are ever grateful for his work.

STOUR DOWNS PARISH Vicar's letter —

Dear all

February can be a gloomy grey month and it can often still be very cold if this January is anything to go by.. Yet amongst this greyness the occasional sunny day and the growth of the early spring flowers bring bursts of light and colour. In the ordinary days after Christmas and before Easter we get those brighter days too. One such day is Valentine's Day – the day where many people celebrate love.

Yet the story of St. Valentine himself may not seem at first to be as bright as we might have hoped. St. Valentine was a third century Roman saint associated with the tradition of courtly love. As you can read in books about the Middle Ages, the story goes that St. Valentine refused to deny his love for Christ before the Roman Emperor Claudius. So, because of this, the Roman Emperor had Valentine's head chopped off. However, before Valentine's head was toppled, the story goes on to reveal that in an act of love and compassion, Valentine restored the sight and hearing of his own executioner's daughter.

This is far removed from the vast industry of cards and gifts that have built up around St. Valentine's Day, when expressions of love matter. It is at the centre of Valentine's story that we find a surprising depth and expression of love; a love that Valentine found and was inspired to follow and make his own. The love of God offered to him through Jesus. A love through which Jesus offered compassion to a world that would crucify Him. A love that Valentine would share with those who jailed and executed him. A love in which Jesus would find the courage to stand up for who He loved; each one of us, just as Valentine had the courage to stand up to Claudius, for his love of Christ.

I hope that this Valentine's you will be embraced by God's love and the love of those around you. And if this Valentine's Day you intend to lose your head over love for someone special, then I pray that the Lord will bless that love, with the depth, compassion and courage displayed by St. Valentine, but even more importantly, through the love God expressed in the gift of his Son Jesus. A gift that says, 'I love you.' So, this Valentine's Day, if the cards don't come and you're left with a feeling of unloved disappointment, I pray that you will remember the gift of true love that is Jesus and know that whether it is Valentine's Day or not, in Him, you are truly loved.
